Appoint Members to the Social Services Transportation Advisory Council (SSTAC)	12/9/08	4-5

RECOMMENDATION

It is recommended that the Board reappoint Janice Galloway to the SSTAC for a three-year term.

SUMMARY

In order to comply with the California Public Utilities Code (Section 99238), the RTPA is required to have a minimum nine-member SSTAC. Members are appointed for three-year terms.

DISCUSSION

The SSTAC is required by state law to make annual recommendations concerning unmet transit needs. The SSTAC consists of community members who represent or are disabled, elderly, or persons of limited means. Members are appointed by the Board for three-year terms. Staff recommends that Janice Galloway be reappointed for a three-year term. The recommended SSTAC roster is attached.

This action is consistent with revised bylaws in the prior item 4-4, or the pre-existing bylaws.

OTHER AGENCY INVOLVEMENT

The SSTAC and the Technical Advisory Committee supports the recommended appointment.

FINANCING

There are no financial impacts associated with appointing citizens to the SSTAC.
