RECOMMENDATION

It is recommended that the board reappoint SSTAC members to three-year terms.

DISCUSSION

The Transportation Development Act requires establishment of a nine-member council consisting of community members representing the elderly, disabled, or persons of limited means. The council provides input on transit issues and prepares the annual unmet transit needs recommendation.

Members of the public interested in joining have been encouraged to apply. There are no new applications. Staff recommends reappointing Kay Hudelson, Del Lockwood, and Lisa White to three-year terms. A current membership roster is attached.

ALTERNATIVES

The board could choose to advertise for new members. This is not recommended as there are no new requests for membership.

OTHER AGENCY INVOLVEMENT

The SSTAC and the Technical Advisory Committee concur with the staff recommendation.
