STAFF RECOMMENDATION:

It is recommended that the board of directors receive an update on Active Transportation Program (ATP) Cycle 7 project assistance.

DISCUSSION:

At SRTA's December 2023 meeting, the board of directors' authorized a \$400,000 contract with Kittelson & Associates to provide project assistance for local partner's projects competing for ATP Cycle 7 capital funding, and authorized staff to apply for a \$700,000 Caltrans grant for preparing local projects for ATP Cycle 8 and other grant programs (weblink: [https://srta.ca.gov/DocumentCenter/View/9224/14 TSA ATP](https://srta.ca.gov/DocumentCenter/View/9224/14_TSA_ATP)). In January 2024, SRTA staff submitted the grant application and Kittelson continued assisting local partners with their ATP Cycle 7 projects, listed in the table below, under a new effort called "Low Stress Shasta." Project preparation, so far, has included community and corridor analysis, project partner meetings, opening public engagement events, stakeholder meetings, and development of initial preliminary engineering drawings.

OTHER AGENCY INVOLVEMENT:

The projects have involved staff from multiple organizations and input from community members within each project's vicinity. The Technical Advisory Committee met on April 11, 2024, to receive an update on the effort.

FISCAL IMPACT:

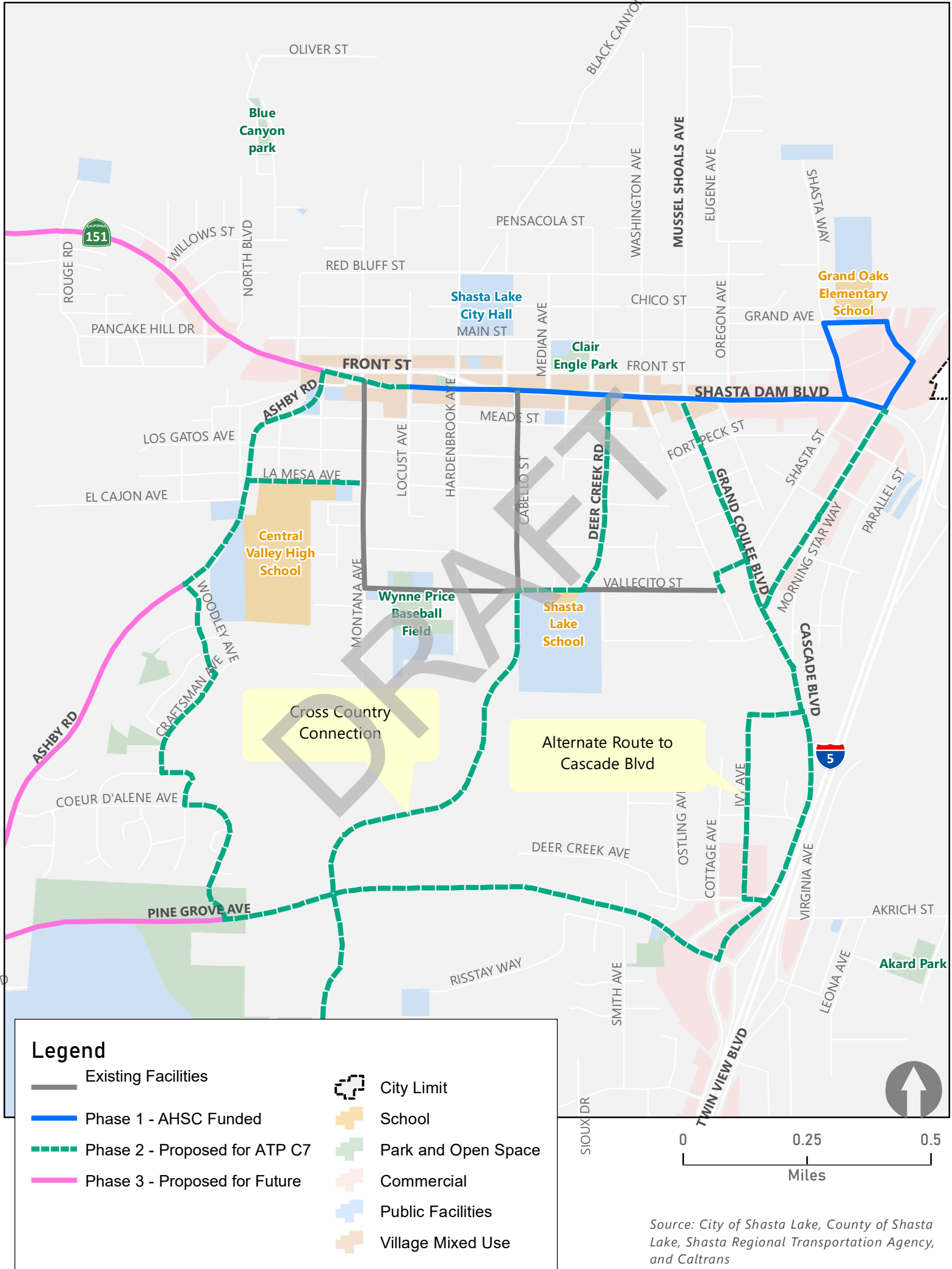
Competitive ATP applications include match equal to 20 percent of a project's cost. Consistent with prior SRTA Board of Directors' direction for successful applications from previous ATP cycles SRTA would provide half the project match (ten percent by SRTA and ten percent by project lead) if awarded funding, using regional non-motorized funds, RTIP shares, or other eligible funds. The task of estimating project costs has just begun. SRTA's contribution toward projects is currently estimated at \$4-5 million, which will significantly assist local agencies if all projects are awarded funding. Final project costs and match information will be provided at a future meeting. The ATP is extremely competitive, such that the region would be fortunate to receive even one award.

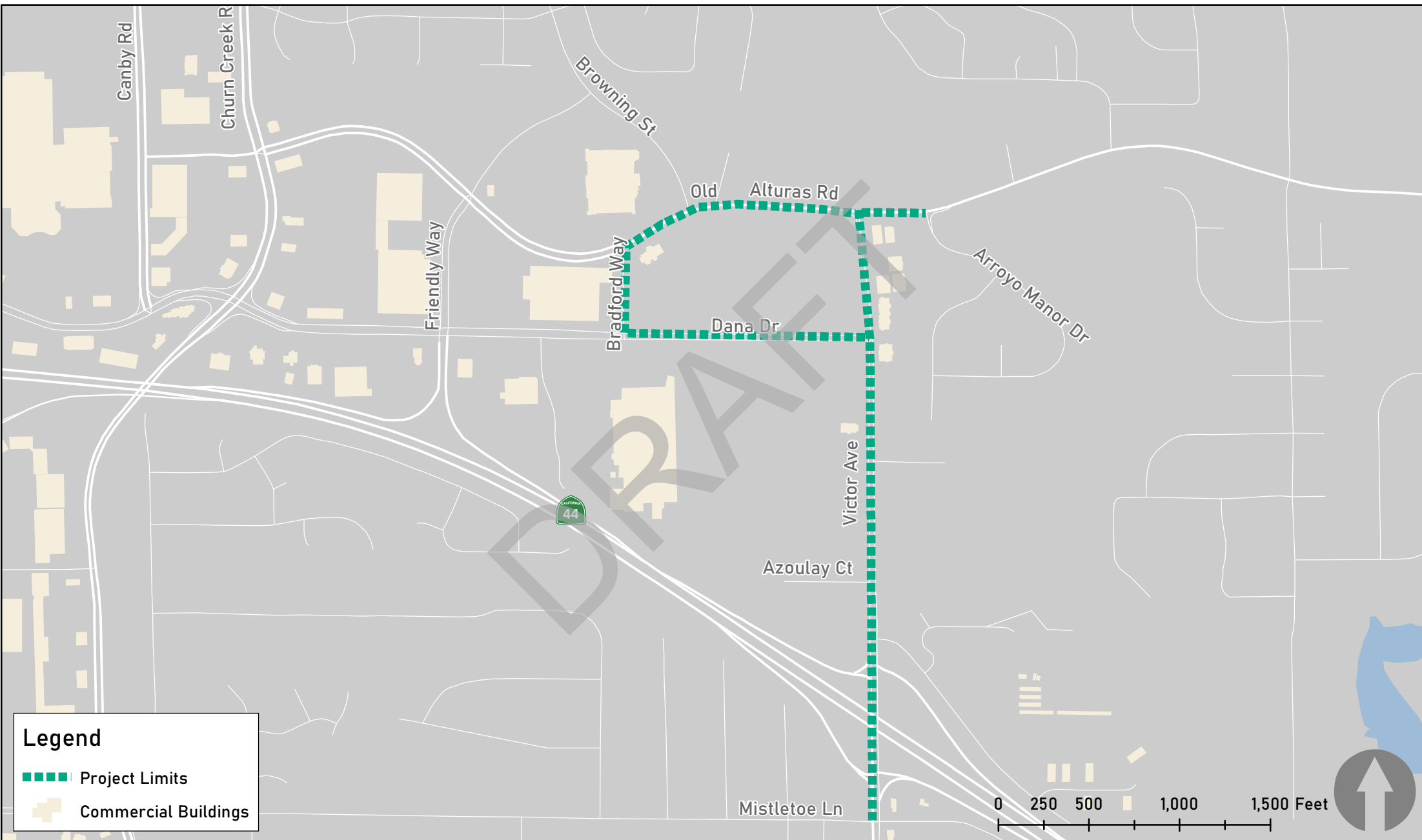

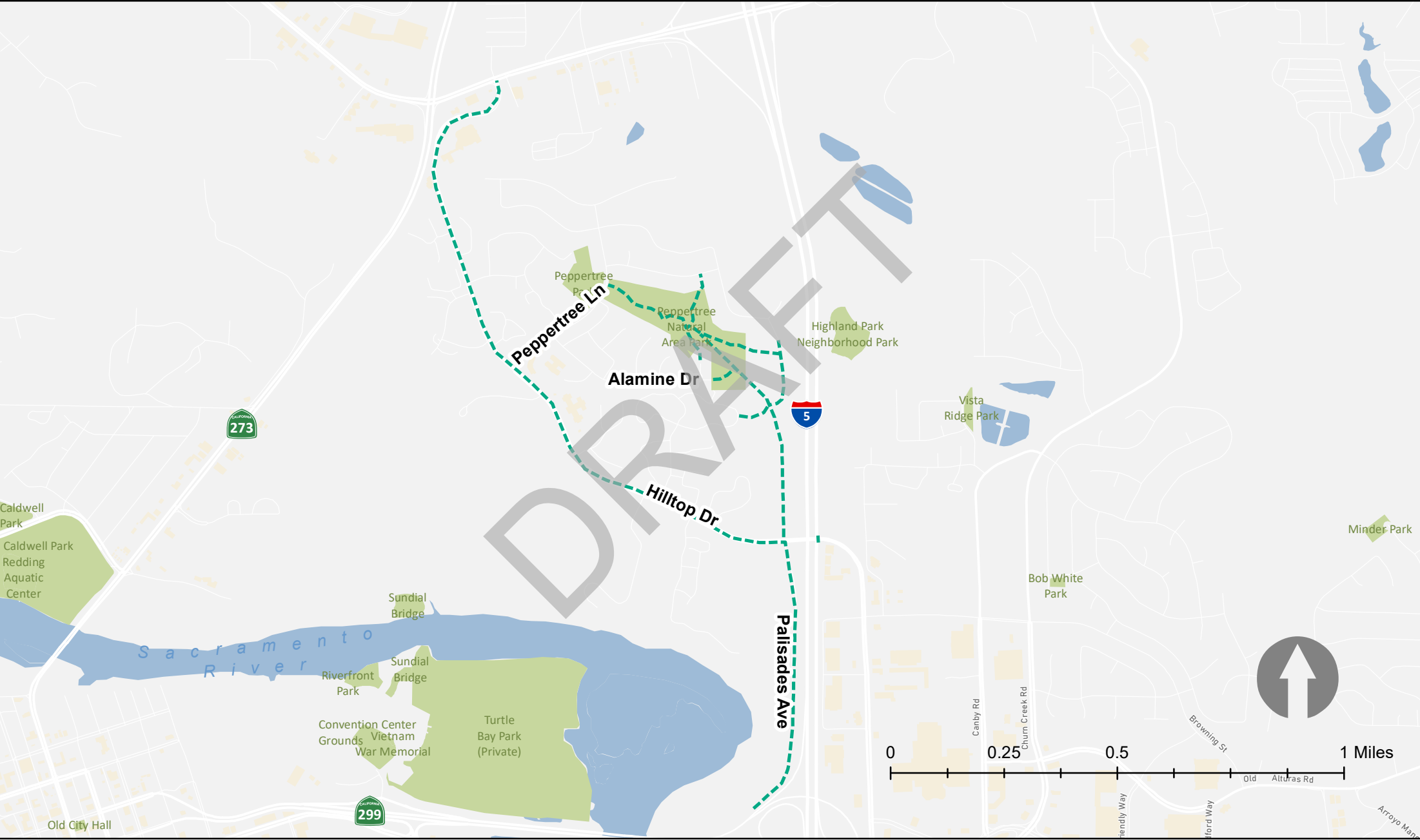
Link Shasta Active Transportation Loop
