SUMMARY:

The Fiscal Year (FY) 2025/26 California State of Good Repair (SGR) estimated allocation to SRTA totals \$315,891 (Attachment A). The Redding Area Bus Authority (RABA) directly receives an additional \$16,442 for eligible transit projects. SGR is administered by Caltrans and provides funding annually for transit capital, rehabilitation, and maintenance projects. RABA requested all the regional funding for preventative maintenance. The SRTA Board of Directors must approve the SGR project list for SRTA to receive the regional allocation and then pass the funds through to RABA.

STAFF RECOMMENDATION:

It is recommended that the board of directors:

1. Adopt Resolution 25-08 (Attachment B), approving the FY 2025/26 SGR project list totaling \$315,891;
2. Approve amending SRTA's State of Good Repair (SGR) policies related to fund distribution to eligible recipients (Attachment C); and
3. Authorize the executive director to make administrative amendments to the approved projects pending final FY 2025/26 SGR allocations by the California State Controller and any necessary documentation required by Caltrans.

DISCUSSION:

The SGR program provides funding for capital projects or services to maintain or repair a transit operator's existing transit vehicle fleet or transit facilities, including the rehabilitation and modernization of the existing vehicles or facilities. Staff recommend edits to SRTA's adopted SGR policy (Chapter 3.26) (Attachment C) to align policies with actual processes for distributing funds to eligible recipients such as RABA. SRTA collaborates with eligible transit operators to develop a list of regionally significant projects and submits a regional project list to Caltrans by September of each year. RABA will be the sole applicant this year and will therefore submit the project list. A history of board agenda items is provided as Attachment D.

SRTA is estimated to be allocated \$315,891 in SGR funds for FY 2025/26 per the January 31, 2025, California State Controller's State of Good Repair Program Allocation Estimate. A final allocation amount will be provided by the State Controller in August. Staff recommend funding preventative maintenance, consistent with SGR Program policies and SRTA's regional priorities. SRTA will pass the funds through to RABA. RABA will be responsible for all reporting on the use of the funds to Caltrans and SRTA. In addition to the regional funding received by SRTA, RABA receives a direct allocation. For

FY 2025/26, RABA is estimated to be allocated \$16,442, which will also be used on preventative maintenance.

ALTERNATIVES:

The board of directors may choose to modify the project list consistent with the FY 2025/26 State of Good Repair Guidelines and SRTA's SGR Policies. This may require RABA to allocate other funds for preventative maintenance needs. The board of directors may request additional information and continue this item to the October board meeting or hold a special meeting prior to the grant submittal due date of September 1, 2025.

OTHER AGENCY INVOLVEMENT:

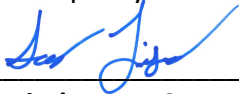
Caltrans administers the SGR Program. SRTA coordinated with RABA and Dignity Health Connected Living (DHCL) to develop the project list. The Technical Advisory Committee (TAC) met on June 11, 2025, to review and discuss the FY 2025/26 SGR project list and concur with staff recommendations.

FISCAL IMPACT:

The recommended action allocates \$315,891 in regional SGR funds for capital needs. This reduces the burden on Transportation Development Act funds that may be used to meet other regional transit needs or other eligible uses. A final allocation will be provided by the State Controller's office in August. Should the regional funding amount vary, staff would notify RABA and make necessary administrative changes to the allocations for each approved project.

FISCAL & POLICY COMMITTEE REVIEW:

The Fiscal & Policy Committee met on June 16, 2025, to review and discuss the SGR project list and proposed policy amendments. The committee concurs with the staff recommendations.

SUBJECT: Fiscal Year 2025-26 State of Good Repair Program Allocation Preliminary Estimate

Enclosed is the summary schedule of State of Good Repair (SGR) program funds available to be allocated for Fiscal Year (FY) 2025-26 for each Transportation Planning Agency (TPA), county transportation commission, and the San Diego Metropolitan Transit System for the purposes of Public Utilities Code (PUC) section 99312.1(c). Allocations for the SGR program are calculated pursuant to the distribution formulas in PUC sections 99313 and 99314. Also enclosed is a schedule detailing the estimated available amount calculated pursuant to PUC section 99314 for each TPA by operator.

PUC section 99313 allocations are based on the latest available annual population estimates from the Department of Finance. Pursuant to PUC section 99314.10, the PUC section 99314 allocations are based on the State Controller's Office (SCO) transmittal letter, Reissuance of the FY 2020-21 SGR Program Allocation Estimate, dated August 1, 2023.

According to the FY 2025-26 proposed California Budget, the estimated amount of SGR program funds budgeted is \$137,953,000. Prior to receiving an apportionment of SGR program funds in a fiscal year, an agency must submit a list of proposed projects to the California Department of Transportation (DOT). DOT reports to SCO the eligible agencies that will receive an allocation quarterly pursuant to PUC sections 99313 and 99314. SCO anticipates the first quarter's allocation will be paid by November 26, 2025. Please refer to the schedule for the amounts that relate to your agency.

WHEREAS, the Shasta Regional Transportation Agency (SRTA) is an eligible project recipient and may receive State Transit Assistance Funding from the State of Good Repair Account (SGR) now, or sometime in the future, for transit projects; and

WHEREAS, the statutes related to state-funded transit projects require a local or regional implementing agency to abide by various regulations; and

WHEREAS, the Road Repair and Accountability Act of 2017 named the California Department of Transportation (Caltrans) as the administrative agency for the SGR; and

WHEREAS, Caltrans has developed guidelines for the purpose of administering and distributing SGR funds to eligible project recipients; and

WHEREAS, the SRTA Board of Directors wishes to approve the Project List for Fiscal Year (FY) 2025/26 for the California State of Good Repair Program; and

NOW, THEREFORE, BE IT RESOLVED by the Board of the Directors of the Shasta Regional Transportation Agency that:

1. The following FY 2025/26 SGR Project List is approved; and

CHAPTER 3.26 STATE OF GOOD REPAIR PROGRAM POLICY

(Amended ~~10/19/2022~~6/25/2025)

3.26.010 - PROGRAM OVERVIEW

- A. The State of Good Repair (SGR) Program is a noncompetitive, formula-based program included under Senate Bill 1: The Road Repair and Accountability Act of 2017 (Beall and Frazier). Funds are deposited into the State Transit Assistance (STA) account and then distributed to regional transportation agencies using the STA Program formula, with half of the SGR funds being allocated according to population (Public Utilities Code (PUC) 99313) and half of the SGR funds allocated according to transit operator revenues (PUC 99314).
- B. The goal of the SGR Program is to provide funding for capital assistance in rehabilitating, modernizing, and maintaining California's existing local transit systems in a state of good repair. These investments will result in transit vehicle fleets that are more reliable and safer and emit less greenhouse gases and other pollutants.

Caltrans administers the SGR Program; details are available in the most current SGR Guidelines published by the Caltrans Division of Rail ~~and Mass Transit~~, located at <https://dot.ca.gov/programs/rail/state-transit-assistance-state-of-good-repair> ~~<http://www.dot.ca.gov/drmr/spstasgr.html>~~. Caltrans' SGR Guidelines related to eligibility and procedures supersede this policy.

3.26.020 - PROJECT ELIGIBILITY

- A. SGR funds are made available for capital projects that maintain the public transit system in a state of good repair. Project eligibility is defined per PUC Section 99212.1 (c), and is summarized below:

1. Eligible Projects and Expenses

- a. Transit capital projects or services to maintain or repair a transit operator's existing transit vehicle fleet or transit facilities, including the rehabilitation or modernization of the existing vehicles or facilities;
 - b. The design, acquisition, and construction of new vehicles or facilities that improve existing transit services;
 - c. Transit-related preventative maintenance, such as engine replacement and general preventative maintenance work; and
 - d. Temporary transit infrastructure that is needed as part of an effort to repair and improve local transportation infrastructure.

All SGR funds must be spent on publicly owned assets.

2. Ineligible Project and Expenses

The SGR Program is a transit capital program. Projects that solely expand capacity or service are not eligible projects. Transit operations, transit agency administration, and program management

are not allowable. Pre-construction phases such as planning and environmental are ineligible on their own but are eligible when included as part of a capital project as long as project development costs do not exceed 20% of the total estimated project cost. See Caltrans' SGR Guidelines for more detail.

3.26.030 - REGIONAL FUNDING PRIORITIES

- A. The Shasta Regional Transportation Agency (SRTA) will support the development and implementation of projects that best achieve the SGR Program goals, meet the transit needs of the region, and make progress towards the transit-related objectives and targets included in SRTA's Regional Transportation Plan (RTP) and other regional planning documents (e.g. Transportation Improvement Program (TIP), short range transit plan, transit asset management plan, etc.).
- B. SRTA will prioritize funding to projects that rehabilitate and modernize the existing regional transit systems, and that do not currently have other sources of funding allocated. The following eligible projects and expenses, in order of priority, will generally guide project selection:
 - 1. Replacement, rehabilitation or modernization of:
 - a. Rolling stock, including replacement of diesel or gas vehicles with hybrid or zero-emission vehicles and replacement of fuel systems with renewable fuel systems;
 - b. Transit or transfer facilities and/or equipment that improves existing transit services (including construction of new facilities and/or equipment);
 - c. Maintenance facilities and equipment, including facility improvements that reduce emissions or rely more on renewable fuel sources; and
 - d. Security equipment and systems.
 - 2. Transit-related preventative maintenance; and
 - 3. Rail station and facility improvements.

3.26.040 - SRTA AND PARTNER ROLES

- A. Caltrans' SGR Guidelines identify the roles and responsibilities of state and regional agencies. The following is a summary of those roles:
 - 1. The **State Controller's Office (SCO)** is responsible for SGR accounting, publishing allocation amounts, and allocating funds to approved agencies.
 - 2. **Caltrans** is responsible for administering the SGR Program, including reporting and maintaining program guidelines.
 - 3. **SRTA, as an Eligible Regional Entity (SCO-designated 99313 recipient)**, is responsible for maintaining SGR funds on behalf of the region, compiling project submittals from Eligible Transit

Operators, submitting the annual Project List for SRTA projects, and submitting annual reporting for SRTA projects.

4. **Eligible Transit Operators (SCO-designated 99314 recipients, i.e. RABA)** are responsible for complying with all relevant SGR Guidelines, including providing SRTA with a proposed annual list of projects. The Eligible Transit Operator's proposed project list must be submitted to SRTA by May 1st of each year in order to be reviewed and recommended for SRTA Board of Directors approval in advance of SGR Project List submittal deadlines. Eligible Transit Operators are responsible for submitting an annual Project List for projects that they will administer, as well as submitting annual reporting for their projects.

3.26.050 - PROJECT MANAGEMENT AND DELIVERY

A. Project List Modification

If regional transit priorities change, a modified Project List and supporting documentation may be submitted to Caltrans for approval. Project List modifications require SRTA Board of Director's approval prior to acceptance by Caltrans.

B. Fund Accrual and Distribution

SRTA receives quarterly allocations of SGR funds and then distributes the funds based on the Caltrans-approved project list to eligible recipients (e.g., transit operators) and/or keeps funds in a separate account for which SRTA is the recipient for project implementation. As the project list is based on estimates and could vary from the actual annual allocations by amounts that would not fully fund multiple projects, or even one project, best practice is for a single project to be the recipient of gains/losses. If an annual allocation of SGR funds is less than the previously provided estimates SRTA will notify eligible recipients of the funding changes. The eligible recipient bears the responsibility to make up the remaining project costs with other applicable funds.

For SRTA projects, if SRTA is not prepared to initiate a project in the current fiscal year or seeks to combine multiple years of funds for a SRTA project, a Project List that includes a project scheduled to begin at a later date must be submitted to accrue funding. Funding may accrue for up to four years. Any fund accrual requires SRTA Board of Directors' approval.

Eligible Transit Operators may submit and request SGR funds to be accrued toward a future project scheduled to begin at a later date, consistent with SGR guidelines. For projects approved by the SRTA Board of Directors, SRTA will deposit funds into a project specific account on behalf of the recipient and make the funds available for use toward the approved project at the appropriate time.

For Transit Operator projects, SRTA will distribute SGR funds within 30 days of receipt from the SCO to eligible recipients unless a project is accruing funds for future use.

C. Contracting

~~Once projects have been approved by the SRTA Board of Directors, they will be referenced in and attached to a local agency's sub-recipient cooperative agreement with SRTA or amended into an existing agreement.~~

~~If the grantee does not have a sub-recipient agreement with SRTA or cannot enter into a sub-recipient agreement, the grantee will be required to enter into a technical services agreement with SRTA. If the grantee cannot enter into a sub-recipient agreement and/or technical services agreement with SRTA, SRTA may be unable to award SGR funds to the grantee.~~

~~No work can begin on a project until a sub-recipient cooperative agreement or technical services agreement is fully executed or amended.~~

D. Invoicing

~~Invoices will be paid on a reimbursement basis for work completed, dependent on receiving SGR allocations from the SCO. Local agencies will provide sufficient documentation to support any invoice. Project updates must be provided quarterly to SRTA in writing.~~

~~Local agencies will inform SRTA of project completion in writing within 30 days of completion.~~

DELEGATE AUTHORITY TO EXECUTIVE DIRECTOR FOR SUBMISSION OF CALIFORNIA STATE OF GOOD REPAIR PROGRAM DOCUMENTS

It is recommended that the board of directors:

1. Adopt Resolution 18-02 delegating authority to the executive director to execute certifications and assurances for the California State of Good Repair (SGR) program and all other required SGR program documents, including possible future amendments with Caltrans and future allocations of SGR funds; and
2. Authorize the executive director to perform all actions necessary to obtain regional allocations in future SGR cycles.

For FY 2017/18, the Shasta Region was allocated \$251,044. After consulting with the Redding Area Bus Authority (RABA), Dignity Health Connected Living, and the county of Shasta, SRTA submitted the following projects for funding by the deadline on January 31, 2018:

- Replacement of two Burney Express vehicles (\$200,000); and
- Accrual of balance (\$51,044) for replacement of one Coordinated Transportation Services Agency vehicle with a low or no emission vehicle for use by Dignity Health Connected Living.

By motion made and seconded (Kehoe/Watkins), and unanimously carried, the consent calendar was approved.

APPROVE PROJECT LIST FOR FISCAL YEAR 2018/19 CALIFORNIA STATE OF GOOD REPAIR PROGRAM

It is recommended that the board of directors adopt Resolution 18-15 approving the FY 2018/19 SGR project list for improving existing CTSA services in the Shasta Region by purchasing new low- or no-emission vehicles.

SRTA submitted a project, using the \$235,099 allocation, to acquire new low- or no-emission vehicles that will improve existing transit services. The cost of each vehicle could range from \$70,000 to \$200,000, depending on the type of vehicle chosen.

By motion made and seconded (Kehoe/Moty), the staff recommendation passed unanimously.
