

**ASSIGNMENT OF CONTRACT BETWEEN
SHASTA REGIONAL TRANSPORTATION AGENCY AND DIGNITY HEALTH CONNECTED LIVING PROVIDING
SPECIAL TRANSPORTATION SERVICES**

This Assignment is entered into as of July 1, 2025, 2025, by Shasta Regional Transportation Agency (SRTA; "Assignor") and the Redding Area Bus Authority (RABA; "Assignee").

WHEREAS, SRTA entered into agreement with Dignity Health Connected Living (DHCL) on July 1, 2017 to provide transportation and coordination of public transportation services ("Agreement"); and

WHEREAS, the Agreement was subsequently amended through Amendment #1 executed on or about November 8, 2019; Amendment #2 executed on or about May 11, 2022; Amendment #3 executed on or about December 19, 2022; and Amendment #4 executed on or about March 19, 2025; and

WHEREAS, SRTA and DHCL wish to have SRTA assign to RABA all of SRTA rights, duties, and obligations included in the Agreement; and

WHEREAS, by virtue of Amendment #4 to the Agreement, DHCL, upon written notice, consented to the assignment of SRTA to RABA; and

WHEREAS, SRTA has given DHCL written notice of its assignment to RABA; and

WHEREAS, SRTA and RABA have entered into a "Memorandum of Understanding by and Between Shasta Regional Transportation Agency and Redding Area Bus Authority for Administration of the Consolidated Transportation Services Agency" that will be executed concurrently with this Assignment.

NOW, THEREFORE, in consideration of the agreement reached between SRTA, RABA, and DHCL, and for other valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. SRTA hereby assigns, transfers, and sets over to RABA all of its rights, title, duties, and interest in and to the Agreement. RABA hereby assumes all of SRTA's obligations under the Agreement and agrees to indemnify and hold harmless therefrom as to obligations occurring on and after the effective date hereof. SRTA hereby agrees to indemnify RABA and hold RABA harmless with respect to SRTA's obligations under the Agreement that occurred prior to the effective date of this assignment. Notwithstanding this assignment, SRTA hereby expressly reserves any and all rights, claims, or defenses that SRTA may have against DHCL under the Agreement or otherwise.
2. SRTA agrees to assign to RABA all funding sources previously used to fund the Agreement including but not limited to Article 4.5 funds through Consolidated Transportation Service Agencies (CTSA).
3. Neither RABA nor DHCL shall subsequently assign the Agreement to a third party or subcontract the performance of its duties and obligations under the Agreement to a third party without the written consent of the other.

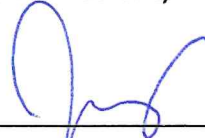

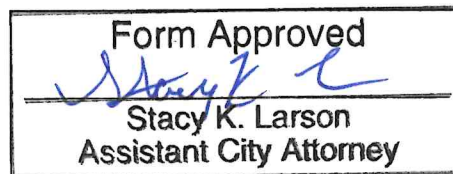

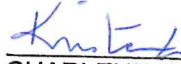
