Subject: Formal Amendment No. 7 to the Shasta 2025 Federal Transportation Improvement Program (FTIP)

Dear Mr. Le:

With the delegation authority provided to me by the Shasta Regional Transportation Agency (SRTA) Board of Directors per attached SRTA Resolution #13-14, dated December 10, 2013, I hereby approve Formal Amendment No. 7 to the Shasta 2025 Federal Transportation Improvement Program (FTIP) for forwarding to California Department of Transportation (Caltrans) for review and recommendation of approval to the Federal Transit Administration (FTA) and Federal Highway Administration (FHWA).

The amendment is consistent with metropolitan transportation planning regulations per Title 23 Code of Federal Regulations Part 450. As amended, the 2025 FTIP is financially constrained, and the attached financial summary confirms that funding is available. Additionally, the amendment is consistent with the 2022 Regional Transportation Plan. Shasta County is in conformance with federal air quality standards.

The amendment notification process complied with SRTA's adopted 2025 Shasta Public Participation and Title VI Plan. The public and interagency review period ran from June 11, 2026, through June 18, 2026, meeting the requisite 7-day review period.

This amendment includes the following programming changes listed below:

- **Grouped Projects for Operating Assistance to Transit Agencies – (CTIPS ID No. 211-0000-0057) – TBLP116 in 2022 RTP**

- Removes \$157,005 in FTA Section 5307 funds from FY2024/25, flexed from FHWA's Carbon Reduction Program, after it was determined RABA's Microtransit project required a scope adjustment to maintain Carbon Reduction Program (CRP) eligibility.
- Programs \$426,050 in FTA Section 5310 in FY2025/26 for operating assistance for the Redding Area Bus Authority (\$186,000, including \$93,025 in toll credits) and Dignity Health Connected Living (\$240,000, including \$120,000 in toll credits).
- Corrects an administrative error by programming \$2,355,000 in SB125 funds in FY2026/27 and \$1,985,000 in SB125 funds in FY2027/28.
- **Grouped Projects for RABA Capital Vehicles (Fare Revenue) - (CTIPS ID No. 211-0000-0059) – TBLP115 in 2022 RTP**
 - Programs \$744,000 in FTA Section 5310 in FY2025/26 funding to RABA to replace four cutaway buses. This project includes toll credits in the amount of \$111,600.
 - Programs \$696k in FTA Section 5310 in FY2025/26 to replace four medium Dignity Health buses. This project includes toll credits in the amount of \$104,400.
 - Programs \$174,000 in FTA Section 5310 funding in FY2025/26 to Paratransit Services to replace a medium, gasoline-powered, cut-away bus. This project includes toll credits in the amount of \$26,100.
- **Grouped Projects for RABA Transit Capital (CTIPS ID No. 211-0000-0060) – TBLP115 in 2022 RTP**
 - Programs \$157,005 in CRP funds in FY2026/27 for RABA microtransit technology such as GPS trackers, routers, and an upgraded security camera system.
 - Minor corrections to funding amounts made in the transition from SRTA's use of the state's programming software (CTIPS) to its own programming software (Ecointeractive). These corrections may show in current reports but do not reflect a change over previous CTIPS reports.
- **Grouped Projects for Bridge Rehabilitation and Reconstruction (CTIPS ID No. 211-0000-0074) – TBLP84 in 2022 RTP**
 - Updates the SHOPP Bridge Program to reflect changes related to the 2026 SHOPP carryover, including increased programming in FY2026/27.
- **Grouped Projects for Safety Improvements SHOPP Collision Reduction Program (CTIPS ID No. 211-0000-0075) – TBLP82 in 2022 RTP**
 - Updates the SHOPP Collision Program to reflect changes related to the 2026 SHOPP carryover.
- **Grouped Projects for Roadway Preservation (CTIPS ID No. 211-0000-0078) TBLP81 in 2022 RTP**
 - Updates the SHOPP Roadway Preservation Program to reflect changes related to the 2026 SHOPP carryover.
- **Grouped Projects for Bridge Rehabilitation and Reconstruction – HBP Program (CTIPS ID No. 211-0000-0083) – TBLP97-99 in 2022 RTP**
 - Updates the HBP Group Project listing in all active years of the 2025 FTIP to align with the list updated by Caltrans Headquarters on March 18, 2026.
- **Grouped Projects for Bicycle and Pedestrian Facilities in Shasta County (CTIPS ID No. 211-0000-0115) – TBLSP100-112 in 2022 RTP**
 - Updates funding information to reflect correct local sources for the Victor Improvement Project. There are \$999k in local funds programmed for the city of

Redding in FY2026/27 and \$1M in Regional Improvement Program funds programmed in FY2027/28. Programs \$204k in non-infrastructure state Active Transportation Program funding for FY2026/27.

- Programs an additional \$19,717 in CRP funds in FY2025/26 toward the city of Shasta Lake's Shasta Dam Blvd. complete streets project for a total of \$999,040 in CRP funding in FY2025/26 programmed toward the project.
- Confirms no new funding for Caltrans District 2's East Palisades Multiuse Path, because the project's funding was unprogrammed from the 2026 SHOPP.
- **Grouped Projects for Safety Improvements – SHOPP Mobility Program (CTIPS ID No. 211-0000-0119) – TBLSP81-83 in 2022 RTP**
 - Minor adjustments to accommodate the transition to SRTA's new programming software.
- **FFY2024 and FFY 2025 Projects from the Pit River Tribe and the Redding Rancheria are added as an appendix to this amendment and an appendix to the original Shasta 2025 FTIP.**
- **A project from the FHWA Federal Lands Highway (FLH) Transportation Improvement Program is also added as an appendix to this amendment and an appendix to the original Shasta 2025 FTIP.**

SUBJECT:	Delegation of Authority to Executive Director to Approve Federal Transportation Improvement Program (FTIP) Formal Amendments

WHEREAS, the Shasta Regional Transportation Agency (SRTA) has been designated as the Metropolitan Planning Organization (MPO) for Shasta County pursuant to U.S.C. Section 134(a) and (g); and

WHEREAS, Title 23 Code of Federal Regulations, Part 450 requires the preparation and adoption of a four-year Federal Transportation Improvement Program (FTIP) by the MPO to become part of the Federal-Statewide Transportation Improvement Program (FSTIP); and

WHEREAS, in order to be consistent with the State Transportation Improvement Program (STIP), the FTIP must be updated every two years; and

WHEREAS, SRTA is responsible for preparing and processing administrative modifications and formal amendments to the FTIP; and

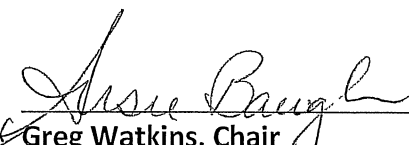
WHEREAS, SRTA's governing board of directors may delegate approval of formal amendments to the FTIP to the executive director of SRTA; and

WHEREAS, the meeting schedule of the SRTA Board of Directors can make it difficult to bring forward formal FTIP amendments in a timely manner.

NOW, THEREFORE, BE IT RESOLVED that the Shasta Regional Transportation Agency delegates authority from the SRTA Board of Directors to the executive director to approve formal amendments to the FTIP under the following criteria:

1. Programming revisions will be consistent with federal and state allocations, and prior SRTA actions;
2. Federal and state FTIP requirements would continue to be followed, as well as SRTA's public participation process; and
3. The executive director will postpone and refer to the SRTA Board of Directors any amendment where such a request is made during the public participation process.

(a) Each year, FHWA will compile the approved TTIPs for all of the Tribes into one document called the TTPTIP. This document will identify all expected projects and activities over a four-year period and will be organized by fiscal year, State, and Tribe.

(b) FHWA and BIA will post the approved TTPTIP on their respective Web sites. A subset of the TTPTIP that identifies only design and construction activities will annually be provided to the pertinent FHWA Division office for further transmittal to each State Transportation Office/Department for inclusion in the STIP without further action per 23 U.S.C. 201(c)(4).

The TTPTIP is a financially constrained prioritized list of transportation projects and activities eligible for TTP funding covering a period of four years that is developed by BIA and FHWA based on each Tribe's submission of their TTIP or Tribal priority list. It is required for projects and activities to be eligible for funding under title 23 U.S.C. and title 49 U.S.C. chapter 53. The Secretary of Transportation reviews and approves the TTPTIP and distributes copies to each State for inclusion in their respective STIPs without further action.
